### **Field / Structure Description**

The format of a delivery notification file is designed to be generated and processed by a wide variety of IT systems and operating systems.

Each line contains exactly one data element. The individual data elements are identified by so-called tag fields. These tag fields consist of ten-digit numbers. The actual data content begins from the eleventh character.

A delivery notification file is hierarchically structured into file-related, message-related, delivery notification-related, order-related, and item-related fields. The file and message-related fields must be delivered only once at the beginning of the message. The delivery notification hierarchy level can reference multiple orders with their respective order items. This structure allows for a **summary of delivery notifications** (multi-delivery notification).

Structure of the PHONONET EDI delivery notification:

- File-related fields (1.1)
- Message-related fields (1.2)
- Repetition per delivery notification, in case of multi-delivery notification (2.1)
  - Repetition per order of a purchase (2.2)
    - Repetition per item of a purchase (2.2.1)
    - End of order of a purchase
  - Delivery notification summary information (2.3)

**Important:** Even for orders with only a few items, or for deliveries from backorders with only one item, the reference to the order (i.e., the purchase) must be established!

**General rule:** Information in higher hierarchy levels applies to all subordinate levels, but can be overridden by specifying it again in the lower level. For example, the shipping method specified in the message-related part can be overridden by a specification at the delivery notification level.

Only fields marked with status 'M' must be delivered (see chapter "Delivery Notification Interface – Tabular Overview"). However, additional fields may be mandatory in specific exchange relationships, especially if the recipient expects certain content as mandatory.

The order of the fields must not be changed. The separation between header information and delivery notification information, as well as at the end of each new delivery notification (including after the last one), is done using tag field <code>0000000002</code>. The separation between delivery notification header and repetition per order is done using tag field <code>0000000000</code>. The individual items (including the last one) are separated using tag field <code>0000000001</code>. The separation of Shipping Unit Number information in the message header is done using identifier <code>0000000003</code>.

Each line ends with CarriageReturn/LineFeed.

The format for delivering all fields is DOS-ASCII Codepage 437.

The EDI delivery notification is usually generated by suppliers on the day of picking, no later than between 18:00 and 23:00. This means the delivery notification is available in the morning, i.e., before the goods arrive. If the goods do not arrive on the same day, it is due to delays by the shipping company. For 'Just in Time' orders, immediate availability of the delivery notification is required.

The PHONONET EDI delivery notification thus provides retailers with advance information about the expected goods. Since this information is provided via EDI, it can be used to automate goods receipt.

Fields 0030008003–0030008008 (repeatable as often as needed!) and 0030023003 represent an optional extension of the format to introduce the shipping unit number (hereafter referred to as SSCC). These optional fields must only be delivered when using SSCC structures. Recipients who cannot process this information must ignore it. Suppliers who wish to provide their customers with additional information should refer to the following structural explanations.

### **Representation of the SSCC Structure**

#### **Optional Extension in the Document Header**

In the header section, a two-level SSCC (Shipping Unit Number or Serial Shipping Container Code) information structure can be defined.

#### **Structure:**

When using SSCC information, the following tag fields are used:

The two hierarchy levels are defined by tag fields <code>0030008003</code> (level 1) and <code>0030008005</code> (level 2). The package descriptions for levels 1 and 2 use <code>0030008004</code> and <code>0030008006</code> respectively, referencing a code list (see code sheet for package types).

- **Level 1 SSCC** describes a higher-level packaging unit (e.g., pallet/carton number <x>).
- **Level 2 SSCC** describes the detailed composition (e.g., box <i> on pallet/carton <x>) of the level 1 unit.

Level 2 can only be used if level 1 is defined. If only one level is used, only level 1 is applied. Level 2 must not be used alone.

Each position in a DESADV must be assigned to a unique SSCC. Not every package needs an SSCC, but it must be ensured that each position can be clearly assigned to one. For example, if a pallet contains several cartons and the pallet itself has no SSCC, then each carton must have one SSCC, if the pallet has an SSCC, the cartons may omit theirs. If both have SSCCs, the position must refer to the carton's SSCC.

The requirements for labeling nested deliveries may vary by trading partner.



#### **Use of the Separator:**

When repeating within a level, entries are separated by the element 0000000003. The final element of a level (with no further sub-objects) is also concluded with this separator.

#### **Example (VBS snippet):**



#### **Explanation:**

This shows two level 1 SSCC entries:

• First: description 1, code PK (carton), SSCC ending in 78, weight 1.5 kg.

• Second: description 2, code PK, SSCC ending in 89, weight 3 kg.

Since there is at least one repetition, they are separated by 000000003. After the second separator, the level is either complete or another repetition follows.

#### To use SSCC information:

- At least one level 1 entry (0030008003 to 0030008004) must be present.
- At least one SSCC description (0030008007) must be included.
- All items (EAN or UPC reference) in the position section must reference the corresponding SSCC via tag 0030023003.

This means: SSCC information in the header **requires** the use of all SSCC tag fields in the position section.

Multiple level 1 SSCCs can occur, each with multiple level 2 SSCCs (e.g., 2 pallets =  $2 \times \text{level 1}$ , each with several cartons = level 2).



#### **Example SSCC illustration as a graphic:**

The graphic represents the previous SSCC illustration. The green rectangles represent positions in the



in-house illustration that represent the reference to the SSCC description via the SSCC reference in the position section "0030023003."

The separators "0000000003" are not shown – a separator must be placed between the SSCC description of the first and last levels. Additional separators must be placed at the last data record of the SSCC description and at the last data record of level 2 before returning to the next data record of level 1. Weight information within the SSCC description is not shown.

#### **Extension of Position Information with SSCCs**

Once SSCC (Serial Shipping Container Code) is used, **each item position must be extended with the field**:

0030023003<SSCC>

#### **Key Rules:**

- This field must only be used if SSCC information is provided in the header section.
- If no SSCC information is present in the header, this field **must not** be used doing so would result in an error on the recipient's side.
- If SSCC information is included in the header, this field becomes **mandatory** (exception: if the delivery quantity is 0, since there is no packaging information).
- The SSCC reference in the item section must match an SSCC defined in the header. If the referenced SSCC is not defined in the header, it is considered an error.

### **Format Description:**

- Tag: 0030023003
- Format: Same as field 0030008007 (i.e., 18-digit SSCC)

#### 1. Document Header

This section describes the **file-related fields** that must be included at the beginning of every delivery notification message.

#### 1.1 File-Related Fields

These fields are used for addressing and file identification.

#### Mailbox Number of Sender (Tag: 0030001001)

- Specifies the sender's mailbox.
- Format options:
  - **Mailbox Number**: 6-digit PHONONET number (e.g., 951200)

#### Mailbox Number of Recipient (Tag: 0030002001)

- Specifies the recipient's mailbox.
- Format options:
  - **Mailbox Number**: 6-digit PHONONET number (e.g., 100757)
- Refer to the PHONONET trading partner list for valid mailbox numbers.

### Interchange Number (Tag: 0030003001)

The interchange number uniquely identifies the sales data report.

- If the PHONONET EDI server is used, this field is automatically filled in by the EDI server.
- In all other cases, the user must fill in this field using the following pattern:

**XXXXXXYYYZZZZZ** 

#### Where:

- xxxxxx = Sender's mailbox number
- yyy = Value "000" (for internal use in PHONONET clearing)

 zzzzz = Incremental counter across all formats/messages sent from the sender's mailbox

#### **Example:**

99999900000000, 99999900000001, ..., 99999900099999, 99999900000000, ...

In the Benelux, the interchange number consists of 14 digits.

#### File Name from Sending System (Tag: 0030003002)

This field can be filled in by the user (alphanumeric, 12 characters, no file extension). If the PHONONET EDI server is used and the user does not provide a value, the server will use the content from the file NUM\_OUT.TXT.

#### Date/Time from Sending System (Tag: 0030004001)

If the PHONONET EDI server is used, this field is automatically filled in by the server. Otherwise, the user must provide the value in the format:

#### YYMMDD:hhmm

#### **Interface Version Number (Tag: 0030004051)**

- Specifies the version of the interface used.
- Format: numeric without separators (e.g., version 2.0 = 20, version 1.8 = 18)
- **Strongly recommended** to include for support and validation purposes.

### 1.2 Message-Related Fields

These fields apply to **all delivery notifications** within a multi-delivery notification message.

### Fields and Descriptions:

- Date (Tag: 0030005001)
  - The date of the multi-delivery notification.
  - Format: YYMMDD
  - Mandatory
- Customer Number (Tag: 0030006001)
  - The retailer's customer number at the supplier.

- For branch connections, this is the customer number of the specific branch.
- Mandatory
- PHONONET Branch Number (Tag: 0030007001)
  - Branch number for chain stores.

  - Total number of shipping units (colli).
  - These may be grouped using transport packaging (e.g., pallets).
  - Optional
- Shipping Method, Coded (Tag: 0030008002)
  - Refer to the code list for shipping methods.
  - Optional
- Level 1 SSCC Element (Tag: 0030008003)
  - Refers to a higher-level packaging unit (typically a pallet).
  - If only one level is used, this refers to the SSCC-addressed unit (typically a carton).
  - Numbered starting from 1.
  - Mandatory/Conditional
- Package Type Code (Tag: 0030008004)
  - Defines the type of packaging using a code list (FACT EANCOM).
  - Mandatory/Conditional
- SSCC (Tag: 0030008007)
  - The 18-digit Serial Shipping Container Code (SSCC).
  - Globally unique identifier for a shipping unit.
  - Optional

  - Numbered starting from 1.

  - Same as above, but for Level 2.

### 2. Summary of Delivery Notifications (Multiples)

This section allows for the **repetition of multiple delivery notifications** within a single transmission document.

#### 2.1 Repetition per Delivery Notification

Each delivery notification can reference **orders from multiple purchase orders**.

#### **Fields and Descriptions:**

• Delivery Note Number (Tag: 0030009001)

Unique identifier of the delivery note assigned by the supplier.

#### **Mandatory**

• Partial Delivery Note Number (Tag: 0030009002)

If a delivery note is split into multiple partial notes, this field indicates the sequence number.

#### **Optional**

• Number of Partial Delivery Notes (Tag: 0030009003)

Indicates the total number of partial delivery notes for completeness checks.

#### **Optional**

Delivery Note Date (Tag: 0030009004)

Creation date of the delivery note by the supplier.

#### **Optional**

• Shipment Number (Tag: 0030009005)

Also known as the "Bill of Lading Number."

#### **Optional**

Package Tracking Number (Tag: 0030009006)

Tracking number provided by the logistics provider.

#### **Optional**

• PHONONET Number of Supplier (Tag: 0030010001)

6-digit PHONONET number of the supplier.

- For delivery notes with items from a single distributor, this number is listed in the header.
- For mixed orders, it must be specified per order or item.

#### **Mandatory/Conditional**

• Supplier Remark (Tag: 0030011001)

Any remarks from the supplier regarding the delivery note.

#### **Fields and Descriptions:**

Customer Order Number (Tag: 0030014001)

Reference to the purchase order (see field '0010005001' in the order data interface).

#### **Optional**

• Supplier's Internal Order Number (Tag: 0030014002)

Internal order number used by the supplier to facilitate customer inquiries.

#### **Optional**

Order Date (Tag: 0030015001)

Reference to the order date (see field '0010006001' in the order data interface).

#### **Optional**

• Supplier Remark (Tag: 0030016001)

Supplier's comment on the order.

#### **Optional**

Remark from Purchase Order (Tag: 0030016002)

Feedback or notes from the retailer included in the original order.

#### **Optional**

Packaging Code (Tag: 0030017001)

Code indicating how the goods were packaged.

Refer to the packaging code list.

#### **Optional**

Promotion Code (Tag: 0030018001)

Code indicating a granted promotion.

Supplier-specific article number (not EAN/UPC).

Must be unique in combination with the PHONONET number.

Mandatory

EAN/UPC (Tag: 0030023002)

EAN or UPC code including check digit.

Formats supported: EAN (13 or 8 digits), UPC (12 or 7 digits).

**Optional** 

• Shipping Unit Number (SSCC) (Tag: 0030023003)

18-digit Serial Shipping Container Code.

Required if SSCC information is used in the header.

**Conditional** 

Title (Tag: 0030023051)

Product or work title, formatted per PHONONET rules.
